## **Introduction**

Ce rapport annuel du Centre Métropolis Atlantique fait état des activités entre le 1er avril 2008 et le 31 mars 2009. Il marque également la seconde année dans la phase III du projet Métropolis (2007-2012). Cette deuxième année de la phase III a été très fructueuse pour le CMA et a vu de nombreuses publications et projets nouveaux, ainsi que plusieurs activités visant le transfert de la connaissance.

Créé en janvier 2004, le Centre Métropolis Atlantique présente les perspectives et les préoccupations de la région atlantique relatives aux politiques stratégiques nationales du projet Métropolis et de ses partenaires fédéraux. Le CMA est affilié à quatre autres centres Métropolis (établis en 1996) et il fait partie d'un réseau transnational lié au projet Métropolis international.

Le CMA œuvre dans les deux langues officielles à partir des bureaux de Halifax et de Moncton, favorisant la promotion d'un dialogue entre les communautés de langues et de juridictions diverses. Forts de l'acquis des universités de la région, les cinq groupes ou domaines de recherche régionaux du Centre permettent de rassembler des chercheurs, des organismes communautaires, des fournisseurs de service aux immigrants ainsi que des responsables de l'élaboration des politiques sur le plan municipal, provincial et fédéral (voir les résumés des domaines à l'annexe 1).

Le CMA a pour but principal de contribuer à l'élargissement des connaissances relatives aux politiques et aux tendances dans le secteur de l'immigration, aux changements et aux migrations de la population ainsi qu'aux priorités et aux programmes relatifs à l'immigration sur le plan régional et national. Étant donné que l'immigration devient depuis quelques années une plus grande préoccupation au Canada atlantique et une réalité plus connue, le CMA concentre ses efforts sur l'attraction, l'intégration et la rétention des nouveaux immigrants dans les communautés anglophones et francophones.

## **Partie I : Objectifs du centre**

### **A. Centre Objectives for 2008- 2009**

- Further develop new research domains aligned with the federal policy research priorities of Phase III of the Metropolis Project, which were created in 2007-2008.
- Foster the development of robust research networks which extend throughout Atlantic Canada, across the country and internationally. These networks include community organizations and policy makers in addition to academic researchers, and provide an interface for pursuing the AMC mandate of policy-relevant research addressing immigration, diversity and population migrations.
- Provide infrastructure and support to the AMC-affiliated researchers who received grants from AMC core research funding, and who attracted additional research funding of \$1,478,663 in the 2008-09 fiscal year in order to help them move their projects forward and bring them to fruition.
- Enhance student training and access to educational opportunities in the fields of immigration and diversity studies. This objective is achieved through the AMC Grant Competition, subsidies for students to attend conferences and the Policy Research Symposium, domain-based employment on AMC-funded research projects, the AMC student internship, among other means.
- Streamline and improve knowledge dissemination capabilities through the introduction of a Knowledge Transfer grant competition, the expansion of the Working Paper Series, a publication distribution project, redesign of the website, the introduction of the AMC video series, and maintenance of the Electronic Bulletin which contains information on upcoming events, including lectures and conferences, research resources and publications, and calls for proposals.
- Award \$125,000 to high-quality and innovative research projects addressing the six federal policy research priorities through the fourth annual AMC Grant Competition. The AMC aims to attract new research affiliates from universities across all four Atlantic Provinces through this competition.

## **B. Overview of Key Center Activities**

### ***Cross-Domain Project***

The Centre's Cross-Domain Project, *Profiles of Immigrant Communities in Atlantic Canada: The role of networks in attracting, retaining and integrating immigrant men and women in Atlantic Canada*, headed by Nicole Gallant, (formerly of Université de Moncton, currently at IRNS, Université de Québec), continued in 2008-09. The CDI team is currently preparing submissions for a special edition of the Journal of International Migration and Integration (JIMI) and is entering phase III of the project (community surveys).

### ***Atlantic Immigration and Diversity Research Archive (AIDRA)***

The Atlantic Immigration and Diversity Research Archive (AIDRA) project, which was completed during the summer of 2007 with funding from ACOA, Canadian Heritage, the NS Office of Immigration, and the Atlantic Metropolis Centre, was fine-tuned by an IT professional in order to increase ease of use and to move the archive to a new web server. The AIDRA is a searchable online database of Atlantic-based immigration-related research. It is the result of extensive consultation with AMC partners across sectors and research conducted by AMC staff and domain-based research assistants. Users may now access the AIDRA through the Atlantic Metropolis Centre website.

### ***2008-2009 Grants Competition and Peer Review Process***

The AMC held a fourth competition, along with a special competition in collaboration with the Atlantic RURAL Centre, to award \$125,000 allocated for grants in the yearly budget. The AMC invited submissions addressing the six federal priority areas of the National Metropolis Project, as well as the overarching theme of the Atlantic Metropolis Centre: *Attraction, Retention and Integration of Immigrants to Atlantic Canada*. For the list of the 1 Special Strategic, 2 Strategic and 6 Pilot Grants awarded, see Appendix 2 (also available from the AMC website). This year's grants competition was effective in attracting new researchers to affiliate with the AMC, both from the Centre's lead universities, and from regional institutions such as UNB Saint John and Saint Francis Xavier. Both Strategic Grants were awarded to researchers who are new affiliates of the AMC, and one of the two grants jointly awarded with the RURAL Centre went to a new affiliate as well. The grants competition has also provided funding to a large number of graduate students for work on a range of projects (see Appendix 10).

### ***Working Paper Series***

Researchers at the AMC produced 14 working papers in 2008-09, a substantial increase over the 4 papers produced in 2007-2008 – a listing is provided in Part III, D.

## **PART II: Knowledge Transfer/ Mobilization Activities**

### **A. Centre and Domain Activities**

#### ***AMC 2008-09 Policy Research Symposium***

The AMC held its 4<sup>th</sup> Annual Policy Research Symposium (formerly Strategic Planning Retreat), May 20-21, 2008 at Université de Moncton, Moncton, New Brunswick. The event was attended by approximately 45 researchers, NGO representatives and government partners.

The meeting included workshops and presentations addressing the following topics :

- **Justice, Policing and Security:** Possible directions for a JPS research agenda within the AMC, and access to justice among immigrants
- **Welcoming Communities:** Recent Korean Immigration in Moncton, NB

Participating federal partners included Citizenship and Immigration Canada, Canadian Heritage, ACOA, Public Safety Canada, and others. NGO partners included Halifax Immigrant Learning Centre, The Association for Newcomers to Canada of Prince Edward Island, le Centre d'accueil et d'intégration des immigrant.e.s du Moncton métropolitain, Sharing Our Cultures, MAGMA and others.

#### ***AMC Open House***

The AMC Halifax office held an "Open House" on December 5<sup>th</sup>, 2008. This event was attended by approximately 40 people, including representatives of NGO partner organizations, government partners, and the lead and affiliated universities. It provided an opportunity for researchers and partners to come together in the AMC office space to meet and network.

#### ***AMC Video***

In order to increase dissemination possibilities relative to AMC-sponsored events a "Movie/Vidéo" page was added to our website, which links to the AtlanticMetropolis YouTube Channel. With the aid of the appropriate technology and software the AMC was able to share three events which occurred in Halifax with the online community.

#### ***AMC 2009-2010 Knowledge Mobilization Strategy***

A plan for 2009-10 Knowledge Mobilization Activities was prepared which includes a Knowledge Mobilization Projects Competition, seminars with leading researchers, brown bag sessions, co-sponsored events, and an initiative to explore and strengthen the policy relevance of working papers and policy briefs.

### **AMC NGO Research Event**

On February 17, 2009, Madine VanderPlaat, AMC Director, gave a presentation to the AMC's NGO partners on the topic of "Constructing a Research Question," as part of the AMC's ongoing capacity-building efforts to develop stronger links between researchers and community partners. The event was held at the offices of MISA-HILC and subsequently made available on the Metropolis website and YouTube Channel.

### **Domain Activities**

Each of the five research domains participated in the creation of networks, partnerships and continued collaboration with other researchers. The domain leaders and members contributed to knowledge mobilization through a variety of activities including domain-sponsored visiting speakers, round tables and meetings and participation at regional, national and international conferences. ## **B. Website**

During 2008-09, the AMC expanded its capacity to disseminate research findings and various other forms of information on its website. As previously mentioned, video capability was introduced to the site, and a major overhaul was done in early 2009, giving the site a more up-to-date and attractive user interface.

## **C. Newsletter**

In 2008-2009 the AMC continued the practice of distributing electronic bulletins which began in 2007-2008, and published its sixth online newsletter in February 2009.

## **D. Media Coverage**

AMC Researchers and affiliates are engaged in research and policy debates which are of significant interest to the public and are regularly asked to provide commentary in the media. In 2008-09, for example, domain leaders were featured on CBC TV as experts on immigration, and AMC-funded research projects received substantial newspaper coverage.

## **Part III: Research**

### **A. Research Projects Supported by Centre Funds: Faculty**

In June 2008 a Call for Proposals was launched for a special strategic grant of up to \$50,000, strategic grants of up to \$20,000, as well as pilot projects up to a maximum of \$5,000. Based on the recommendations of an external review committee, a total of 9 projects were supported. In addition, a special grant competition in conjunction with the Atlantic RURAL Centre was launched in October 2008, for which a review committee awarded two grants of \$15,000, for which the AMC contributed \$5000 each. ## **B. Additional Research Funding Attracted by AMC Researchers**

In 2008-09, researchers affiliated with the AMC secured \$1,478,663 in new external funding. This combined with the \$342,391 in existing funding totals \$1,821,054 in ongoing grant activity. This figure is significantly higher than that reported last year, in large part because a number of major projects were awarded in 2008-2009 while several large multi-year projects came to an end in 2007-2008. A detailed list of externally-funded projects is presented in Appendix 12.

## **C. Research Outputs**

In 2008-09 researchers affiliated with the AMC produced 5 books (with 4 accepted for publication and 2 submitted), 15 book chapters (with 5 accepted for publication and 2 submitted), 14 journal articles (3 accepted for publication and 5 submitted), 14 Working Papers and 1 other publication (with 6 accepted and 4 submitted). ## **PART IV: Networks and Partnerships**

### **A. Regional and National Partnerships, Collaborations and Networking**

The AMC engages in partnership, collaboration and networking activities aimed at developing research capacity, increasing the profile of the centre, leveraging research funds, and extending the research network. These activities, at both the centre and domain level, extend beyond the events listed in Part II, section A. Staff from the Halifax AMC office participated in meetings of the Multicultural Networking Committee hosted by Canadian Heritage. Robert Nathan (AMC Coordinator) attended the ARAISA Conference in Charlottetown in November and the Knowledge Mobilization Conference hosted by the Harris Centre at Memorial University in Saint John’s in October. Marguerite Cassin and Robert Nathan met with representatives of federal government departments under the auspices of the Living Leadership program of the Canada School of Public Service to network and develop an understanding of the AMC with diverse federal agencies. All of the domain leaders engage with academic, government and NGO partners locally and nationally on a regular basis, both through the domain committees and in project-based research work.

## **B. Governance Partners**

The AMC provides for direct input into Centre planning and activities to government policy makers, representatives of the lead universities, and NGOs through their memberships on the Centre's Board of Directors, its Program and Dissemination Committee (the central planning committee of the Centre), and its Domain Committees. Membership on the 2008-2009 Board of Directors and P&D Committee can be found in Appendices 6 and 7 respectively. For a complete list of the AMC's government and NGO partners, see Appendix 8. The AMC structure of governance also provides for government and NGO membership on its peer-review Research Evaluation Committee. ## **C. International Linkages and Collaborations**

AMC Researchers continued to expand networks internationally and strategically build linkages with colleagues working on migration issues in a number of countries in Europe, Africa, Asia and Australasia.

Evie Tastsoglou is involved in team-editing a book on "*Gender, Diversity and the Practice of Citizenship: Challenges and Possibilities in a Local / Global World*" with Margaret Abraham (Hofstra University, New York), Esther Chow (American University, Washington), and Laura Alipranti (National Centre for Social Research, Athens, Greece). The book is a peer-reviewed publication with Ashgate Publishers, expected in the fall of 2009. It includes selected papers from an international conference that the team organized in Athens, Greece in 2007 for the Research Committee on "Women in Society" (RC 32) of the International Sociological Association. A great deal of that publication focuses on international migration. In addition, Dr. Tastsoglou participated in the last three years in a large EU-based project, FEMIPOL, funded by the European Commission. The project ended last May and E. Tastsoglou was invited to Brussels for the final international workshop where she was the policy commentator. She also gave a paper on the concept of "immigrant integration." A number of European research teams participated from various countries (Germany, U.K, Italy, France, Spain, Portugal, Greece, Cyprus, Poland, Slovenia).

Evie Tastsoglou and Alexandra Dobrowolsky also organized events in Halifax with colleagues from overseas. These events include a public lecture by Dr. Xanthi Petrinioti (Department of International and European Studies, Panteion University, Athens; Co-Director of the Mediterranean Migration Observatory), a talk by Dr. Cecil Foster (novelist and Professor of Sociology and Anthropology at Guelph University) and a lecture by Dr. Vijay Agnew (Professor of Social

Sciences, York University. These events were partially sponsored by AMC and Research Domain funds.

Christophe Traisnel a travaillé sur Le rôle de l'immigration francophone dans la construction du discours identitaire des mouvements communautaires en Acadie, au Québec et en Wallonie. Cette recherche exploratoire lui a permis de développer un certain nombre de contacts en Belgique, notamment avec la Fondation Wallonne, basée sur le campus de Louvain-la-Neuve, l'Institut Jules Destrée, la revue communautaire wallonne "Toudi", avec certains groupes communautaires de la ville de Bruxelles, ainsi qu'avec des spécialistes des questions d'immigration et d'intégration (CEDEM, Université de Liège).

The three AMC directors as well as domain leaders Evangelia Tastsoglou and Alexandra Dobrowolsky, in addition to AMC affiliates George Maicher, Fernando Nunes, Jan Sheppard Kutcher, and Bernard Delpeche, attended the 14<sup>th</sup> International Metropolis Conference in Bonn, Germany, where they networked with colleagues from around the world and made presentations.

#### **D. Support from Consortium Universities**

The Halifax node of the AMC remains in a 987 sq. foot office space in downtown Halifax at the rate of \$16,346.64/year, until the Atrium Building, currently under construction at Saint Mary's University, is completed, at which point office space will be provided free of charge by the university. This cost is currently shared between Saint Mary's University and Dalhousie University. In addition, Saint Mary's pays for fax, telephone and internet as well as providing a photocopier through its lease program. The Moncton node is housed at the Université de Moncton where facilities are provided free of charge.

Each of the partner universities contributes a course release for its domain leaders (\$32,000). In addition, Moncton, Dalhousie and Saint Mary's each contribute \$8,000 in course releases for the Directors. Saint Mary's also provides accounting and administrative services to the AMC as well as technological support. Dalhousie and Moncton provide financial services, research services and office supplies.

In addition, lead and partner institutions provided travel funding for Centre researchers and fellowship funding for graduate student training.

#### **E. Non-Research Project Specific Funding from Federal Departments**

Human Resources and Social Development provided \$7000 to the AMC to support student participation at the 11<sup>th</sup> National Metropolis Conference in Calgary. With this funding, the AMC was able to pay registration, travel and accommodation costs for six students from four universities in three Atlantic provinces.

## **PART V: Training Activities**

A total of 14 students and 1 non-student were provided with training opportunities in 2008-09 through paid employment. The majority of these individuals were employed as research assistants on AMC or externally-funded research projects.

Seventeen student theses thematically linked to Metropolis interests or priorities were produced or underway. A sample of theses completed include:

## **Part VI: Budget Projections for 2009-2010**

### *Office Staff*

The proposed budget for office staff in 2009-2010 is as follows:

Halifax Node:       \$82,000

Moncton Node:       \$50,000

There are two staff in the Halifax node office. Robert Nathan replaced Lachlan Barber as the Centre Coordinator and Communications Officer in July 2008. Shiva Nourpanah was hired on part-time basis to replace Rebecca Rolfe in March 2009. Franklin Fezeu continues to work on a part-time casual basis as the AMC web master. A student intern, Yulduz Kutlieva was hired from October 2008 until March 2009 to work on special projects.

In the Moncton node administrative duties were shared by two part-time employees: Tania Duclos and Eric Thomas, both of whom were replaced in fall 2008. The current part-time employees of the Moncton node are Mathieu Lanteigne and Valérie Roy.
