## **Introduction**

Ce rapport est le troisième rapport annuel du Centre Métropolis Atlantique et il fait état des activités entre le 1er avril 2006 et le 31 mars 2007.

Créé en janvier 2004, le Centre Métropolis Atlantique présente les perspectives et les préoccupations de la région atlantique relatives aux politiques stratégiques nationales du projet Metropolis et de ses partenaires fédéraux. Le CMA est affilié à quatre autres centres Metropolis (établis en 1996) et il fait partie d'un réseau transnational lié au projet Metropolis international.

Le CMA œuvre dans les deux langues officielles à partir des bureaux de Halifax et de Moncton, favorisant la promotion d'un dialogue entre les communautés de langues et de juridictions diverses. Forts de l'acquis des universités de la région, les huit groupes ou domaines de recherche régionaux du Centre permettent de rassembler des chercheurs, des organismes communautaires, des fournisseurs de service aux immigrants ainsi que des responsables de l'élaboration des politiques sur le plan municipal, provincial et fédéral (voir les résumés des domaines à l'annexe 1).

Le CMA a pour but principal de contribuer à l'élargissement des connaissances relatives aux politiques et aux tendances dans le secteur de l'immigration, aux changements et aux migrations de la population ainsi qu'aux priorités et aux programmes relatifs à l'immigration sur le plan régional et national. Étant donné la population décroissante, l'exode de la population et le nombre relativement peu élevé des nouveaux immigrants au Canada atlantique, le CMA concentre ses efforts sur l'attraction et la rétention des nouveaux immigrants dans les communautés anglophones et francophones.

## **Partie 1 : Objectifs du Centre pour l'année III**

### **A. Objectifs du centre pour 2006-07**

- Développement de la série de documents de travail pour permettre la diffusion des résultats des recherches financées par le biais du concours de subvention du CMA ou d'autres projets auxquels participent des chercheurs du CMA.
- Offrir une infrastructure et un appui aux chercheurs affiliés au CMA ayant reçu un financement de base du CMA pour la recherche et qui ont été en mesure d'obtenir un financement additionnel de 663 220 \$ tout en continuant de travailler avec les subventions existantes d'une valeur \$701,661.
- Préparation pour la transition à la Phase III du projet Metropolis, incluant la mise au point des priorités et la restructuration des domaines.

- Création d'une capacité régionale en recherche et en données sur l'immigration et la diversité, en particulier chez les universités participantes, dans le but de créer une base solide pour la dimension atlantique des projets de recherche pancanadiens et pour les projets de recherche régionaux.
- Amélioration de la formation des étudiants et accès aux possibilités pédagogiques pour les secteurs de l'immigration et des études sur la diversité.
- Recherche et création de liens et de partenariats internationaux permettant au CMA de produire une recherche comparative et transnationale sur les développements mondiaux ayant un impact au Canada et au Canada atlantique dans des domaines comme les mouvements de population, les questions relatives aux réfugiés et à la sécurité, le marché du travail et les possibilités économiques ainsi que les opinions sur le multiculturalisme et la diversité.

## **B. Overview of Key Center Activities**

### *Cross-Domain Project*

The Centre's Cross-Domain Project, *Profiles of Immigrant Communities in Atlantic Canada: The role of networks in attracting, retaining and integrating immigrant men and women in Atlantic Canada*, headed by Nicole Gallant, Université de Moncton, continued in 2006-07. Interviews and surveys, along with dissemination of research findings through publications, conference presentations, and workshops are planned for 2007-2009.

### *The AMC Data Initiative*

2006-07 saw the completion of the AMC Data Initiative and the submission of a comprehensive Environmental Scan designed to familiarize researchers with data pathways, data-use infrastructure, and sharing arrangements for the use of data from large data sets such as the Longitudinal Survey of Immigrants to Canada (LSIC), the Ethnic Diversity Survey (EDS), the Longitudinal Administrative Database (LAD), and the Longitudinal Immigrant Database (IMDB).

### *Atlantic Immigration and Diversity Research Archive (AIDRA)*

The Atlantic Immigration and Diversity Research Archive (AIDRA) project was carried out during the 2006-07 fiscal year, with funding from ACOA, Canadian Heritage, the AMC and the Nova Scotia Office of Immigration. The AIDRA is a searchable online database of Atlantic-based immigration-related research. It is the result of extensive consultation with AMC partners across sectors and research conducted by AMC staff and domain-based research assistants.

### *2006-07 Grants Competition and Peer Review Process*

Following the model developed for the first Grants Competition in 2005-06, the AMC held a second competition to award \$100,000 allocated for grants in the yearly budget. The AMC invited submissions addressing the overarching theme of the Atlantic Metropolis Centre: *Attraction, Retention and Integration of Immigrants to Atlantic Canada* as well as specific priorities identified by the Program and Dissemination Committee for 2007-07. For the list of the eleven Strategic and Pilot Grants awarded see Appendix 2 (also available from the AMC website). The Grants competition was effective in attracting new researchers to affiliate with the AMC, both from the Centre's lead universities, and from regional institutions such as the University of Prince Edward Island. The grants competition has also provided funding to a large number of graduate and senior honours students for work on a range of projects (see Appendix 13).

### *Working Paper Series*

Researchers at the AMC produced 4 working papers in 2006-07 – a listing is provided in Part IV: C.

### *AMC Open House*

The AMC Halifax office held an "Open House" on December 1st, 2006. This event was attended by approximately 50 people, including representatives of NGO partner organizations, government partners, and the Academic Vice-Presidents of the lead universities.

## **PART II: Partnerships, Collaborations and Networking Activities:**

### **A. Centre Activities**

The AMC provides for direct input into Centre planning and activities to government policy makers and NGOs through their memberships on the Centre's Board of Directors, its Program and Dissemination Committee (the central planning committee of the Centre), and its Domain Committees. Membership on the 2006-2007 Board of Directors and P&D Committee can be found in Appendices 8 and 9 respectively. For a complete list of the AMC's government and NGO partners, see Appendix 10. The AMC structure of governance also provides for government and NGO membership on its peer-review Research Evaluation Committee.

During 2006-2007 the AMC worked on expanding its network of university researchers. Dr. Chedly Belkhodja participated in a roundtable in PEI and an outreach meeting at the University of New Brunswick (Fredericton); Dr. Marjorie Stone organized an outreach meeting with interested researchers at Mount Allison University; In collaboration with the Multicultural Association of Fredericton, Lachlan Barber, the AMC's Coordinator gave a presentation for members and partners of MCAF in Fredericton. Approximately 30 people were in

attendance. In addition the AMC's annual retreat was held at Memorial University in St. John's Newfoundland, May 14-15, 2007.

**D. Support from Consortium Universities**

The Halifax node of the AMC continues to lease a 987 sq. foot office space in downtown Halifax for \$6000/year. This cost is shared between Saint Mary's University and Dalhousie University. In addition, Saint Mary's pays for fax, telephone and internet as well as providing a photocopier through its lease program. The Moncton node is housed at the Université de Moncton where facilities are provided free of charge.

Each of the partner universities contributes a course release for its domain leaders (\$32,000). In addition, Moncton, Dalhousie and Saint Mary's each contribute \$8,000 in course releases for the Co-Directors. Saint Mary's also provides accounting and administrative services to the AMC as well as



technological support. Dalhousie and Moncton also provide financial services, research services and office supplies.

In addition, lead and partner institutions provided travel funding for Centre researchers and fellowship funding for graduate student training.

#### **E. Non Research-Project specific Funding from Federal Departments**

Canadian Heritage provided the AMC with \$5000 to support travel and conference costs of the NGO sector participants in the Toronto National Conference.

## **Part V: Budget Projections for 2007-2008**

### Office Staff

During the 2006-2007 fiscal year, the Halifax office went through a number of staffing changes. ## **Part VI: AMC 2006-07 Strategic Planning Retreat**

The AMC held its 3rd Annual Strategic Planning Retreat, May 3-4 2006 at Saint Mary's University in Halifax. Approximately 80 researchers, NGO representatives and government partners attended the event, a 50 per cent increase in attendance from the 2005 Retreat.

#### ***Research Domain Objectives:***

The Gender, Migration and Diversity/ Immigrant Women research domain provides a unique entry point to identify issues of particular relevance to immigrant women that might otherwise be overlooked. The objective is to provide a regional and national focus for gender-based analysis of immigration and diversity.
