HIGHLIGHTS 2012-2013

This was the extension-year of the AMC, during which time the focus was on closing down the operations and wrapping up existing research projects.

The AMC created paid research opportunities for 26 students and AMC research affiliates supervised seven Master's and nine PhD theses.

Scholars affiliated with the AMC produced 78 publications, 35 conference papers and generated \$364,700 in new, external research money.

The AMC and its domains delivered 42 knowledge translation/mobilization activities.

1.0 INTRODUCTION

Ce rapport annuel du Centre Métropolis Atlantique fait état des activités entre le 1er avril 2012 et le 31 mars 2013. Il marque également l'année de l'extension de la phase III du projet Métropolis (2007 — 2012). Cette dernière année a été très fructueuse pour le CMA en dépit des préparations pour clôture, et a vu l'achèvement de nombreux projetset publications, ainsi que plusieurs activités visant le transfert de la connaissance.

Créé en janvier 2004, le Centre Métropolis Atlantique met en évidence les perspectives et les préoccupations de la région atlantique relatives aux politiques stratégiques nationales du projet Métropolis et de ses partenaires fédéraux. Le CMA est affilié à quatre autres centres Métropolis (établis en 1996) et fait partie d'un réseau transnational lié au projet Métropolis international.

Le CMA a pour but principal de contribuer à l'élargissement des connaissances relatives aux politiques et aux tendances dans le secteur de l'immigration, aux changements et aux migrations de la population ainsi qu'aux priorités et aux programmes relatifs à l'immigration sur le plan régional et national. Étant donné que l'immigration devient depuis quelques années une plus grande préoccupation au Canada atlantique et une réalité plus connue, le CMA concentre ses efforts sur l'attraction, l'intégration et la rétention des nouveaux immigrants dans les communautés anglophones et francophones.

Le CMA œuvre dans les deux langues officielles à partir des bureaux de Halifax et de Moncton, favorisant la promotion d'un dialogue entre les communautés linguistiques et de divers milieux. Grâce à l'appui des universités de la région, les cinq groupes ou domaines de recherche régionaux du Centre peuvent rassembler des chercheurs, des organismes communautaires, des fournisseurs de service aux immigrants ainsi que des responsables de l'élaboration de politiques sur le plan municipal, provincial et fédéral (voir les résumés des domaines dans l'annexe A).

The AMC is managed by three Directors – Dr. Madine VanderPlaat, Saint Mary's University (lead university), Dr. Chedly Belkhodja, Université de Moncton and Dr. Marguerite Cassin, Dalhousie University. The five domains/priority areas housed at the AMC are briefly described below. Detailed information on each of the domains is presented in Appendix A.

Canada's immigration program, like its multicultural approach to inclusion, is designed to bring benefits to Canadian society as well as an offer of a better life to immigrants, refugees, and their immediate families. It is not only the Canadian economy that feels the effects of immigration. Accordingly, the *Citizenship, Social and Civic Integration/ Citoyenneté et intégration sociale, culturelle et civique* domain looks at the social and cultural effects of immigration and diversity on Canada and will determine the extent to which there are risks to societal well-being, to full participation of the members of these groups as citizens, and to the cohesion of Canadian society overall. (Domain Leader: Dr. Pauline Gardiner-Barber, Dalhousie University)

Les communautés accueillantes examinent la capacité d'un pays à recevoir et à intégrer les immigrants, les réfugiés et les membres de minorités repose sur de nombreux facteurs d'ordre social, dont plusieurs peuvent être grandement influencés par les politiques gouvernementales. Cette priorité de recherche permettra de déterminer quels instruments de politique publique sont les plus propices à contribuer à la capacité du Canada, de ses villes et de ses collectivités à recevoir et à intégrer avec succès les immigrants, les réfugiés et les membres de minorités. Elle présentera également l'occasion d'identifier, selon des méthodes empiriques, des pratiques exemplaires qui pourront être adaptées de sorte à être mises en œuvre dans d'autres contextes. (Domain Leaders : Dr. Sylvia Kasparian et Dr. Cristophe Traisnel, Université de Moncton)

The *Economic and Labour Market Integration* research domain investigates the economic effects of immigration, economic performance of immigrants and the role of socioeconomic factors in attracting and retaining immigrants in smaller and rural communities. (Domain Leaders: Dr. Ather Akbari, Saint Mary's University and Dr. Ted MacDonald, University of New Brunswick)

The *Gender, Migration and Diversity/ Immigrant Women* research domain provides a unique entry point to identify issues of particular relevance to immigrant women that might otherwise be overlooked. The objective is to provide a regional and national focus for gender-based analysis of immigration and diversity. This domain has a specific focus on the *Family, Children and Youth* policy priority area. (Domain Leaders: Dr. Evie Tastsoglou and Dr. Alexandra Dobrowolsky, Saint Mary's University).

Concerns over social cohesion and national security, especially the contemporary preoccupation with terrorism, have raised the public profile of debate surrounding how Canada and its justice and security systems can ensure a balanced and fair approach to an increasingly diverse population - to maintain order, public safety and national security while preserving civil liberties and the Canadian multicultural model of an open, diverse society. These are the challenges facing the *Justice, Policing and Security* domain. (Domain Leaders: Marie-Andrée Pelland, Université de Moncton and Margaret Denike, Dalhousie University)

2.0 Training Activities

A total of 28 students and five non-students were provided with training opportunities in 2012-2013. The majority of these individuals were employed as research assistants on AMC or externally-funded research projects. This figure also includes three students hired as office assistants to help with various projects at the AMC. Table 2.1 indicates the number of students who have participated in the AMC in various capacities during the reporting period.

3.0 Research

3.1 Publications

In 2012-2013 researchers affiliated with the AMC produced 5 books, 26 book chapters, 2 special journal issues, 30 journal articles, and 17 other publications. Table 3.1 depicts the distribution of publications across domains. There is slight duplication of numbers across domains due to the

inter-disciplinary nature of some of the works. A full list of publications is included in Appendix C.1.

4.0 Knowledge Transfer/Mobilization Activities

At the end of the 2011-12 fiscal year most of the funds for knowledge mobilization were transferred to the Domains. Events sponsored by the Centre included the public lecture “*Departures After Social Collapse: The German Transatlantic Migration After the Second World War*” delivered by Alexander Freund at Pier 21 and “the Atelier international: Les horizons dépassés du multiculturalisme” in collaboration with la Faculté des arts et des sciences sociales et le Groupe de recherché, in Moncton. Meanwhile AMC staff continued to provide dedicated and full support to run domain events as well as to other two major conferences that took place in Halifax throughout the year. One of these conferences was the 6th Annual Conference of Canadian Association for Refugee and Forced Migration Studies (CARFMS) titled *Spaces of Refuge: Exploring Practices, Perceptions and Policies in Forced Migration and (Re)Settlement*. It was the first time in the Association’s history that the annual conference was held outside Ontario, hosted by the Atlantic Metropolis Centre and Saint Mary’s University. This very successful conference attracted about 100 participants from various parts of Canada, and delivered eighteen concurrent panels, two plenaries and two keynote addresses. In addition, the AMC directors Madine VanderPlaat and Chedly Belkhodja sat on the Steering Committee of the 15th National Metropolis Conference, titled *Building an Integrated Society*, which took place in Ottawa.

4.1 Domain Activities

Each of the five research domains participated in the continued development of networks, partnerships and collaboration with other researchers. The domain leaders and members contributed to knowledge mobilization through a variety of activities including domain-sponsored visiting speakers, round tables and meetings and participation at regional, national and international conferences.

AMC and its domains have delivered 45 events this past year (see Table 4.1 below). The full list of events is available in Appendix D.1.

5.0 Network Activities

5.1 Regional and National Partnerships, Collaborations and Networking

The AMC engages in partnership, collaboration and networking activities aimed at developing research capacity, leveraging research funds, and maintaining the extended research networks in the previous years. Domains have established successful local partnerships which include:

SSHRC, CIC, Canadian Heritage, Status of Women Canada, Nova Scotia Advisory Council on the Status of Women, Nova Scotia Department of Education; Immigrant Settlement and Integration Services (ISIS), Multicultural Association of Nova Scotia (MANS), Maritime Centre of Excellence for Women’s Health, Nova Scotia Office of Immigration, Immigrant Women’s Group, YMCA, Pier 21 Newcomers Program, and the Atlantic Population Table. Details of individual partners for each domain are listed separately in Appendix A.

All of the directors and domain leaders continued to engage with academic, government and NGO partners locally and nationally on a regular basis, mostly in project-based research work. Staff from the Halifax AMC office participated in various meetings, public lectures and conferences. The AMC provided travel assistance to three NGO representatives who presented at this year’s National Metropolis Conference in Ottawa. In addition the directors, domain leaders, staff and other academic affiliates have organized, presented and participated in workshops, plenaries and roundtables.

5.2 International Linkages and Collaborations

AMC researchers continued to expand networks internationally and strategically build linkages with colleagues working on migration issues in a number of countries in Europe, Africa, Asia and Australasia. They networked with colleagues and institutions, organized panels, and sat on academic competition juries that were held in various countries. They have also visited several countries, such as Germany, Greece, and the Philippines, in pursuit of collaborations, academic exchanges and knowledge dissemination activities.

6.0 Governance and Budget

In the past, the AMC provided direct input into Centre planning and activities to government policy makers, representatives of the lead universities, and NGOs through their memberships on the Centre's Board of Directors, its Program and Dissemination Committee (the central planning committee of the Centre), and its Domain Committees. This year, all the committees were defunct except the Centre's Board of Directors which continued to provide direction during the 2012-13 SSHRC extension year. Membership on the 2012-2013 Board of Directorw can be found in Appendix E.

Serperi Sevgur was the full-time staff-member as the Centre Coordinator and Communications Officer in the Halifax node. Golsa Kafili (graduate student) and Mert Ozturk (undergraduate student) have also provided logistical support for various events, as well as remaining active in distributing promotional materials and notices for events across Halifax campuses. In the Moncton node, Éric Thomas was hired as full time staff to conduct the administrative and coordination duties.

6.2 Budget

This year the AMC did not receive funding from SSHRC, and the remaining monies (\$46,497) from last year's budget were used to maintain the office.

6.3 Support from Consortium Universities

The Halifax node of the AMC operated from a suite of offices in the Atrium Building, at Saint Mary's University. The space at Suite 213 has been generously donated by the University. In addition, Saint Mary's covered all expenses related to telecommunications. The Moncton node is housed at the Université de Moncton where facilities were provided free of charge.

In the past each of the partner universities contributed a course release for its domain leaders (\$32,000). In addition, Moncton contributed \$5,000, while Dalhousie and Saint Mary's each contributed \$8,000 in course releases for the Directors. This year only Saint Mary's provided a course release to its Domain Leaders and Director. Saint Mary's also continued to provide accounting and administrative services to the AMC as well as technological support. Dalhousie and Moncton both provided financial services, research services, computers and computer support and office supplies.

In addition, lead and partner institutions provided travel funding for Centre researchers and fellowship funding for graduate student training.

7.0 Future Planning

The Atlantic Metropolis Centre will hold its final annual symposium at Saint Mary's, on May 3, 2013. This will be an opportunity to reflect on what has been learned, what challenges were encountered during the Metropolis years, and what pressing questions await new or further research. There will be five panels, each designated to one of our domains. Speakers will include the domain leaders and commentators drawn from the NGO, government and University sectors. Each panel will be followed by general discussion. Approximately 75 people are expected to attend this event. Please see Appendix D2 for the agenda.

Last year, under the guidance of Dr. Terry Murphy, Chairman of the AMC, AMC was very active in promoting the new partnership proposal "Pathways to Prosperity", headed by Dr. Vicki Esses at University of Western Ontario, which succeeded in receiving a SSHRC partnership grant. Both Terry Murphy and Chedly Belkhodja, Director of AMC based at Université de Moncton are co-applicants of the new project, while other directors as well as many of the AMC domain leaders and affiliates are academic collaborators. The launch of this new Partnership means that collaborative research in matters of immigration and integration will continue, building on the considerable momentum that has already developed in this field.

Furthermore, the Board of Directors have approved the establishment of a separate fund under the title Atlantic Immigration Research Fund. This fund, which will be administered by a representative Management Committee, and will direct the use of the residual funds from the National Metropolis Conference to maintain the momentum that had been achieved through AMC in the area of collaborative, policy-relevant research on immigration and integration in the Atlantic region.

Canada's immigration program, like its multicultural approach to inclusion, is designed to bring benefits to Canadian society as well as an offer of a better life to immigrants, refugees, and their immediate families. It is not only the Canadian economy that feels the effects of immigration. Accordingly, this domain will look at the social and cultural effects of immigration and diversity on Canada and will determine the extent to which there are risks to societal well-being, to full participation of the members of these groups as citizens, and to the cohesion of Canadian society overall and in its regions.
